TOMLF HONORS FALLEN USAF RESCUE HEROES BY SUPPORTING THEIR SURVIVING CHILDREN IN COMPLETING POST-SECONDARY EDUCATION WITHOUT INCURRING DEBT. THE ORGANIZATION MAINTAINS LONG-TERM CONTACT WITH FAMILIES FROM THE TIME OF THE SERVICE MEMBER'S DEATH THROUGH THE POST-SECONDARY GRADUATION OF THEIR DEPENDENT CHILDREN.
